



## **Basketball Refresher on New Rule for Designated Spot Throw-in Locations**

*Answer either A or B in the following scenarios.  
None of the common fouls involve the new bonus situation.*

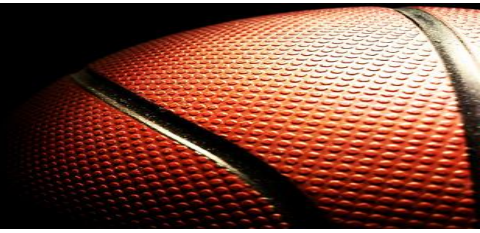
**A. SAME as last year (spot nearest foul, violation, or other stoppage)**

**B. NEW (ball will be handed from one of the designated four spots on the floor closest to the foul, violation, or other stoppage)**

1. Team A in control in the backcourt, Team B charged with a common foul.
2. Team A in control in its front court, Team B charged with a common foul.
3. Team A is charged with a player control foul in its back court.
4. Team A is charged with a player control foul in the front court.
5. Team A dribbling the ball in its back court, when the coach requests a time out.
6. Team A is dribbling the ball in its front court when the coach requests a time out.
7. Team A is dribbling and throws the ball out of bounds in its back court.
8. Team A is dribbling and throws the ball out of bounds in its front court.
9. Team A dribbling in its back court and Team B deflects the ball out of bounds in the back court.
10. Team A dribbling in its front court and Team B deflects the ball out of bounds in the front court.



11. Team A is handed the ball out of bounds in its back court after traveling by Team B, and the thrower causes a violation by stepping over the line.
12. Team A is handed the ball out of bounds in its front court after traveling by Team B, and the thrower causes a violation by stepping over the line.
13. Team A is in the front court when the coach of Team B gets a technical foul.
14. Team A in the back court when the coach of Team A is charged with a technical foul.
15. Team A is dribbling in the front court when Team B player is charged with an intentional foul.
16. Team A is dribbling in the back court when Team B is charged with an intentional foul.
17. Team A throws the ball out of bounds in its back court, close to the division line. Team B is correctly handed the ball near the division line in their front court. Coach of Team B requests a time out which is granted. After play resumes, where is the ball put in play in B's front court? Next to the division line or one of the four designated spots?

13. Team A is in the front court when the coach of Team B gets a technical foul. **B: After Team A gets 2 shots**
14. Team A in the back court when the coach of Team A is charged with a technical foul. **B: After Team B gets two shots**
15. Team A is dribbling in the front court when Team B player is charged with an intentional foul. **B: After Team A player gets 2 shots**
16. Team A is dribbling in the back court when Team B is charged with an intentional foul. **A: After Team A player gets 2 shots**
17. Team A throws the ball out of bounds in its back court, close to the division line. Team B is correctly handed the ball near the division line in their front court. Coach of Team B requests a time out which is granted. After play resumes, where is the ball put in play in B's front court? Next to the division line or one of the four designated spots?
- If a team requests a time out just prior to or during a front court throw-in resulting from an out-of-bounds violation, the throw-in spot DOES NOT MOVE to the nearest of the four designated front court spots. After the conclusion of the time out, the ensuing throw-in must be made from the original designated spot, where the ball went out of bounds.**
